# Kaduna gears up for LG elections



### **KDSG** gears up for LG elections

Following the landmark judgement of the Supreme Court on July 11, 2024, Kaduna State Government has put structures in place for a hitch-free LG poll. This is just as aspirants of the two dominant political parties, the All-Progressives Congress (APC) and the People's Democratic Party (PDP), have commenced campaigns.

ince the 1999 Constitution became operational, the status of Local Governments has been in contention amongst politicians, scholars and lawyers in Nigeria. Amongst major stakeholders, there is confusion as to whether Local Government is a tier of Government or an administrative unit. In other federal systems of Government, the federating units are the Central and State

Governments and this is clearly spelt out because Local Governments or Counties are regulated by State Governments. However, in Nigeria, the issue is ambiguous and this has brought about some contradictions, which the 1999 Constitution has sustained. Section 7(1) states emphatically that "the system of local government by democratically elected local government councils is under this constitution

guaranteed; and accordingly, the government of every state shall, subject to section 8 of this constitution, ensure their existence under a Law which provides for the establishment, structure, composition, finance and functions of such councils". Yet, section 7 (6a) submits that "the National Assembly shall make provisions for statutory allocation of public revenue to Local Government Councils in the federation." Section 7 (6b) added more confusion to the status of Local Governments in Nigeria. It states that "the House of Assembly of a state shall make provisions for statutory allocation of public revenue to local government councils within the state". Furthermore, the confusion has been reinforced in Section 162 (6), where the Constitution established the State Joint Local Government Account for the purpose of payment of "all allocations to the Local Government councils of the State from the Federal account and from the Government of the State". In Section 162(7), the Constitution directs State Government to pay to Local Government councils its total revenue on the terms prescribed by the National Assembly. Indeed, various attempts to remedy the situation by Constitution amendment have failed. In May 2024, the Attorney-General of the Federation, Lateef Fagbemi (SAN), filed suit marked SC/CV/343/2024 at the Supreme Court to

strengthen the autonomy of the Local Government areas. On July 11, the Apex Court delivered its verdict and in his judgement, Justice Agim directed that Local Government allocations from the Federation Account should be paid directly to them henceforth. In addition, the judgement restrained Governors " from collecting funds belonging to the Local Government councils when no democratically elected local

government councils are in place." Also, the Supreme Court ordered that "henceforth no state government should be paid monies standing to the credit of the local government councils." After the landmark judgement, most states started gearing up for the conduct of Local Government elections, especially where there are Caretaker Chairmen in office. In particular, Kaduna State Government is all set for the Council polls and the elections are billed to hold on October 19, 2024. In fact, the Kaduna State Independent Electoral Commission(SIECOM) has already issued a timetable to guide stakeholders. On July 16, SIECOM issued notice of Local Government Council General Election to registered political parties and the public. On the same day, it released election guidelines, election timetable and signalled the commencement of election campaign.

# Local governments and aftermath of the supreme court judgement.

he wild jubilation that greeted the Supreme Court judgment of July 11, 2024, in the suit filed by Lateef Fagbemi (SAN), Attorney-General of the Federation, and Minister of Justice to strengthen the autonomy of the local government councils as guaranteed by the 1999 constitution, is understandable. But the judgment has unwittingly sustained the erroneous impression that the myriad of problems confronting the local government administration would be fixed with its "cure all" directive that the federal government should henceforth credit local government accounts directly. The other reason for the uncontrolled celebration, especially by some commentators who hold governors responsible for the poor state of the councils, is that having been finally set free by the apex court from the "suffocating apron strings" of the "notorious "state governors, the councils would witness rapid development. What a delusion!

In Nigeria, state governors have been singularly held responsible for the nation's apparent lack of development, while in fact the federal government, the real culprit, continues to get away with blue murder. Mere directors in the federal ministries, departments and agencies (MDAs) have done more damage to the country than the 36 state governors put together.

The other decisions of the court include; the reaffirmation of democratically elected local government system as opposed to caretaker committees, declaring dissolution of councils illegal, and withholding of funds to councils without elected officials. But, as expected, the judgment affirming the financial independence of the 744 councils was the most celebrated because everything is about money.

While being cautious not to dampen the enthusiasm of the hosanna group, there is the need for them to tamper their expectation with some reality checks. For instance, the fact that many of the 36 states and the Federal Capital Territory (FCT) have remained pathetically underdeveloped despite receiving their allocations directly and enjoying relative independence is enough reason for the hosanna choristers to tamper their exuberance with extreme caution, because the judgment wouldn't substantially change the fortunes of the councils.

The grouse with the Supreme Court judgement is that it unfortunately and tragically reduced the fundamental problems confronting the councils; the lack of capacity, absenteeism, negative attitude to work, corruption and the weak structure of the local government system etc, into simply a funding issue. The fact remains that unless these issues are critically addressed, the hosanna songs would sooner than later turn into lamentations and an agitation for the return to

the much-derided joint account.

The Supreme Court judgment will not, by a stroke of the pen, improve the quality of candidates running the councils!

It's doubtful if the Supreme Court judges ever read the World Bank Report: Attacking Poverty. According to the report "poorly functioning Public Sector institutions (like local governments) and weak governance are major constraints to growth and equitable development in many developing countries". So, it's not enough for the court to have made the consequential orders without taking into consideration the systemic problems that would definitely defeat the expected outcome. Without a systemic reform that would ensure improved quality of elected and public servants running the councils, the judgment would not achieve the intended objective.

The problem confronting the councils is certainly not the lack of financial autonomy, but the appalling lack of capacity. So, the focus should be on tackling headlong the lack of capacity, issues of over staffing, poor revenue generation, endemic corruption etc, which are responsible for poor service delivery and the acceleration of the socio-economic development at the grassroots. Financial autonomy can't make the councils responsive, nor accountable, just as the hood doesn't make the Monks.

Several studies by multilateral institutions have clearly established that "individual investment projects are less likely to succeed in a distorted policy environment and that neither good policies nor good investments are likely to emerge and be sustainable in an environment with dysfunctional institutions and poor governance." It follows that if the purpose of governments at all levels is to accelerate development and reduce poverty, then reforms and strengthening of the councils that will ensure effective performance, must be undertaken especially at the level of the councils which Robert W. Flack describes as the "foundation of democracy."

Unknown to many Nigerians, the glaring absence of capacity at the local government levels led to the introduction of the Primary Health Care Under One Roof policy and donor agencies demand that primary healthcare centers be managed by the state governments.

The Supreme Court judgment confirms the penchant of Nigerians to chase shadows, of motion without movement and refusal to address fundamental questions.

The nation seems to be afflicted with citizens with very short memories, hence they seem to have forgotten that the joint account was a reaction to the failure of the councils to meet their monthly obligations to teachers, health workers and the people. With certainty, you would want to predict that teachers and health workers will soon start having salary problems.

#### **Expectations from the October 19 LG polls**

esidents of Kaduna and environs have reacted to the Supreme Court Ruling granting financial autonomy to LGAs across the country.

Barring any last-minute change, Kaduna State Government on its part is set to conduct local government elections after an inertia of over three years.

The election, first to be held under the present administration of Governor Uba Sani is coming at a significant milestone in the history of local governments in the fourth Republic, considering the Supreme Court judgement affirming the financial independence of the third tier of government and mandating the federal government and other relevant fiscal allocation agencies to henceforth discontinue the joint allocation arrangement where local governments' monthly allocations are embedded in those of their state governments.

This has been an age-long development, which civil societies and stakeholders blamed for the slow pace of delivering of dividends of democracy at the grassroots level. This is more so that the local government is considered the closest to the people amongst the other tiers.

The Governor of Kaduna State Senator Uba Sani must be commended for taking a bold step of timely setting in motion measures to conduct of LG's election which many analysts and opinion leaders spoken to by the Kaduna Outlook believe will boost the credibility of his administration and earn it accolade among citizens.

Local government election though, conducted by umpires appointed by state governments go a long way in underscoring one of the fundamental principles of democratic experiment in our contemporary practice as it allows citizens the franchise to choose their leaders and equally gives the opportunity for emergence of popular candidates at the helm of affairs at grassroots level.

This will preserve the faith of people in

democracy and give them a sense of belonging as important stakeholders in the project of building the society via the present democratic experiment.

The Kaduna LG's election slated for October 19, 2024 will take place across 23 local government areas in 255 wards in the state which will produce 23 chairmen and 255 councilors as elected officials of their local governments and wards respectively.

People in the state, particularly at the grassroots level are already in the mood for election. Our reporters observed beehive of activities at various offices of political parties with series of meetings were being held in connection with the forthcoming election.

A potential aspirant of a major political party who pleaded for anonymity in an interview with this magazine expressed optimism in the forthcoming exercise, saying the election would elicit deep interest and huge enthusiasm in the history of local elections in the state.

"The latest development of making local governments financially autonomous will without doubt add flavour in the contest because the stakes are now believed to be high for whoever grabs the seat.

"Unlike in the past when chairmen of local governments were believed to have limited powers of how and when to get their resources which were under the full control of their state chief executives.

"Contestants and their parties, I believe will do a lot of campaigning to woo the electorates which will arouse interest and make the contest keen and interesting," he stated.

An official of one of the political parties noted that it was imperative for the umpire to uphold fairness in the discharge of its responsibilities in the forthcoming exercise to avoid post-election litigations that usually arise due to irregularities. He emphasized the need for a truly independent election umpire which he said must not be compromised. He commended Governor Uba Sani for taking the bold initiative among his peers of conducting an election at local government levels.

On his part, an opinion leader who simply identified himself as Musa Kajuru enjoined the electorates to shun violence during and after the exercise, adding that hooliganism could only lead to destruction and backwardness.

He also urged potential candidates and their parties to emphasize peace and orderly conducts during campaigns, saying it would go a long way in ensuring a rancor-free atmosphere all over the

Our correspondents who went to town sampling the opinion of citizens about the forthcoming election observed a growing enthusiasm, rising interest and willingness to contribute in the political discourse surrounding the upcoming exercise.

This wasn't unconnected with the financial autonomy granted local governments and developments that may follow, according to an administrative staff of a local government in a rural area of the state.

According to him, people are curious and eager to see how robust the implementation of the financial independence granted LGs will be visavis promoting and facilitating growth, prosperity, development and above all impacting positively on the welfare of communities, especially in these hard times of escalating prices of essentials items and goods.

He harped on transparency, accountability and judicious expenditure by the would-be chairmen of the post autonomy era of the closest tier to people.

The official who preferred to speak on anonymity said the whole essence of granting local governments autonomy could be defeated if the bosses of this tier failed to give priority to the welfare and the basic needs of the people at the grassroots, who should be the primary beneficiaries of the positive development of the new present dispensation.

KDSG denies brutalizing Kano local politician

he Kaduna State Government has distanced itself from a viral visual where a local Kano politician was being allegedly brualized by some unknown assailants allegedly on the directives of Gov. Uba Sani.

The Governor has since ordered an investigation into the matter which some commentators describe as a badly written and acted script meant to embarrass Gov Uba Sani.

A statement on the matter signed by Alhaji Muhammed Lawal Shehu, Chief Press Secretary to the Governor read in full:

"The attention of the Kaduna State Government has been drawn to a video that has gone viral showing one Dan Balki Commander being whipped by unidentified persons. In the video, accusing fingers were pointed at the Kaduna State Government.

The Kaduna State Government wishes to strongly disassociate itself from the heinous act. It is not in our character. Such barbaric acts have no place in a decent society.

We stand for the rule of law and due process. Our administration is anchored on justice, equity, fairness, inclusivity and respect for the dignity of the human person.

Since assuming office in May 2023, Kaduna State Government under the able leadership of Senator Uba Sani has been working assiduously to rebuild trust and give all citizens of the State a sense of belonging. We accommodate all shades of opinion and have created a conducive atmosphere for all political views to thrive.

The Governor of Kaduna State is a longstanding fighter for fundamental rights and freedoms. He has never wavered in his commitment to the promotion and protection of civil rights, rule of law and due process. He will not, under any circumstances, detail anyone to brutalize a person for holding a contrary opinion.

#### Tudun Biri drone attack victims get N275m relief



overnor Uba Sani has said that 275 million naira of the money donated to the victims of the accidental military drone attack on Tudun Biri has been distributed in the community. He said at the ground breaking ceremony of resettlement scheme in Tudun Biri Friday that there are still some unredeemed pledges to the community.

Gov Uba Sani appealed to individuals, Public and private institutions who made pledges to please redeem them, as Mr. President and the Vice President had done.

He expressed the state government's appreciation to the President, Bola Ahmed Tinubu, for picking Tudun Biri for the groundbreaking ceremony of the Resettlement Scheme for Persons Impacted by Conflicts. "This is a clear demonstration of Mr. President's commitment to wiping off the tears of the Tudun Biri people, and indeed the poor, vulnerable and underserved in our country. Mr. President feels the pains of the internally displaced persons and all those affected by conflicts in our country. He recognizes the fact that decent accommodation and essential infrastructure are critical

to the preservation of human dignity", the Gov further said.

"Since the unfortunate incident, we have supported the victims, their families and members of the community with relief materials through the Kaduna State Emergency Agency (KADSEMA). Direct cash support has been given. Medical and psycho-social support to the victims and their families are ongoing," he added.

Gov Uba Sani announced that a 6km asphaltic road to Tudun Biri Village was under construction which when completed, will open up Tudun Biri Village, link it to other communities, boost agriculture in the area, and ease the movement of persons and goods. He said, a Skill Acquisition Centre was under construction and a Clinic to cater for the medical needs of the people.

Gov Uba Sani recalled that shortly after the unfortunate incident, public and private institutions, as well as public-spirited individuals donated funds to alleviate the suffering of victims and families of those affected and extended gratitute to the institutions and individuals for their show of compassion and empathy.

He thanked the Committee led by the Dep Gov, Dr. Hadiza Sabuwa Balarabe for their commitment and thoroughness in the handling of the cases of victims.

The Gov commended the Vice President Kashim Shettima for effectively facilitating the strategic meetings that fine-tuned the Implementation Plan for the Resettlement Scheme, as well as the Chairman and members of the Steering Committee of the Resettlement Scheme for their commitment and dedication.

"This scheme is the brainchild of Mr. Vice President. He leveraged his experience in managing conflict and persons impacted by conflict in Borno State," Gov, Sani said.

He said that under the project, handled by NEMA, four Resettlement Communities will be built in Igabi, Ikara, Giwa and Kauru LGAs for internally displaced victims of banditry, adding that houses, hospitals and schools would also be built to enable the victims to start life afresh.

He said that Kaduna State Government has allocated lands to NEMA in Igabi, Ikara, Giwa and Kauru LGAs for the construction of the four resettlement communities, and that the land title documents have been perfected by the Kaduna Geographic Information Service (KADGIS).

He assured that the State Government was working closely with federal security forces to degrade and uproot bandits from their enclaves and restore peace and stability to our troubled communities. "We look forward to the day when displaced victims of banditry will return to their original communities and start the process of rebuilding their lives", he said.

Christened G2P/P2G (Government to People/People to Government), the initiative is the brainchild of Dr Abdul Isiaq, Special Adviser on Stakeholders Relations to the Governor, Sen. Uba Sani and synergetic collaboration of Special Advisers and Assistants on Stakeholders Relations, Community Engagement and Relations, Support Groups, and Public Affairs

As the name suggests, G2P/P2G is a platform which beams government policies, plans, projects and programs to the people. In reverse, it views, needs and aspirations of the people to government. This is in line with His Excellency, Sen Uba Sani's avowed commitment to nurturing citizens engagement and rural transformation as the main pillar of Kaduna State Government which leads.

G2P/P2G is an inclusive and diverse mechanism through which stakeholders, including marginalised or non-represented groups receive authentic government information and provide input and feedback to government.

Members said they had been engaging with the Kaduna State Government for over 20 years for the acquisition of the property, which has finally happened during his time in office.


The ACF stated this when members paid a courtesy call on the Governor at Sir Kashim Ibrahim House, Kaduna.

Before Kaduna State Government embarked on the reform of the councils, in 2015 at least 15 of the 23 local governments in the state were bankrupt and couldn't afford to pay salaries without the support of the state government, nor were they able to execute any meaningful project.

Without doubt, the responsibilities of local government councils are becoming much more complex and so has governance by the day. For instance, computer literacy has certainly become a must for the leadership and workers, just as thinking out of the box to attract funding is the way to go. Elected officials must possess special skills and have deep understanding of issues to solve critical problems facing their various communities. These issues have been swept under the carpet by the Supreme Court and would definitely come back to haunt the country.

So, technically speaking, the joint account was a solution to a myriad of problems. The councils need surgical reforms and only the state governments can save the day, because the operators can't muster the necessary political will to embark on it. And like all reforms, surgical operation on the local council system is bound to bring pains, but without it, the system will eventually collapse.

The stark choice before the nation is reform and survive, or refuse to reform and stagnate. We need to copy from countries with effective local government system. Singapore, for instance, invested heavily in education and offers competitive compensation for public servants and aligned their salaries

with private sector standards which ensures that its councils are ran by competent hands.

The blame for non-performance constantly heaped on lack of financial autonomy of the local councils is misplaced, a classic case of a bad workman quarrelling with his tools.

Kaduna state has not only reformed the local government administration system, but has put in place significant laws which has ensured that the councils are on a solid footing to meet the aspirations and yearnings of the people. The same can't be said about other states.

Therefore, the jubilation over the recent Supreme Court judgment is premature. Those celebrating should stop strutting until the outcome is seen then we can all collectively shout uhuru. A country cannot run on rhetoric's but, rather, on the effectiveness of the system. The failures in infrastructure and service delivery are symptomatic of bureaucratic inefficiency and until the systemic reforms are made, the local government councils will not deliver services to the people regardless of court rulings or the amount of money they receive.

The envisaged reform must resolve several issues impeding public service efficiency, address low productivity, redundancy, duplication of roles, high proportion of aged workers, and the issue of unskilled staff. While the state governments cannot usurp the powers of the councils, they can help remove the impediments that hinder the councils performance which is precisely what the reforms would do.

We must stop demonizing the states. It certainly wasn't in any way the desire of the state governments to subjugate the councils to its control, but rather a higher duty to society that they function effectively to the benefit of all.

Between July 23 and August 23, political parties are expected to conduct their primaries, with SIECOM as observer. Before then, the Commission has reserved July 30 as the date for the collection of Forms KDCF 001 and KDCF 001A as well as Data Form for aspirants, amongst other forms. August 21 is the deadline for the submission of all forms. The next day is reserved for the collection of nomination forms KDCF 4F and KDCF 4G from SIECOM's Local Government Area offices across the State. Thereafter, candidates can commence the payment of non-refundable deposits and presentation of tellers to the Commission. Between August 29 and August 31, the Commission will commence the verification and sorting of forms. On September 2, SIECOM will publish the personal particulars of candidates in their constituencies. Between September 9 to 16, the Commission will screened councillorship and Chairmanship candidates at its zonal office and headquarters respectively. On September 20, the list of validly nominated candidates will be published. By 11: 59 pm of October 18, all campaigns must stop and on October 19, the Local Government election will hold. Before the release of guidelines, Senator Uba Sani, the Kaduna State Governor, had earlier sworn in Hajiya Hajara Muhammad as the Chairperson of the Kaduna State Electoral Commission (SIECOM). In addition, Dr. Malan Noel Haruna and Dr.

Fatima Adamu Kera were also sworn in as Permanent Commissioners of the State

Electoral Commission. Similarly, the Deputy Governor, Dr Hadiza Balarabe, swore in Alhaji Abubakar Sadik Musa, Alhaji Ahmed Yahaya, and Halima Sani Aminu, to complete the required number of Commissioners as prescribed in the SIECOM enabling law. Besides, the Kaduna State House of Assembly passed a bill to amend the State Electoral Law No 2 of 2021, jettisoning the use of electronic voting machines. In 2018, SIECOM had conducted local government elections via Electronic Voting Machine (EVM) but Section 3 of the amendment bill deleted the phrase "Electronic Voting Machine". In the new bill, the term "Ballot Box" means a receptacle for the collection of ballot paper, adding that the term "Electronic Device" be deleted wherever it appears in the body of the Law. In addition, the term "Ballot Receipt" has been deleted. According to the law, verification and voting would be done through the use of a manual voter register with the Commission providing ballot papers and ballot boxes for the conduct of election. Right now, aspirants from the two dominant political parties have started indicating interests to occupy the 23 Local Governments in Kaduna State, as their fliers are all over the social media, flaunting their credentials. In addition, they have started reaching out to the electorate, unveiling their plans for their constituents. At the latest, primaries will hold on August 23 where the flagbearers who will slug it out on October 19 will emerge.

"He enjoined electorates and other relevant stakeholders to be active politically and monitor developments after election to see if truly there are changes and positive impacts of the autonomy on the lives of citizens,"

Elsewhere, the Kaduna Outlook interviewed a grassroots advocate of good governance who expressed optimism in the Supreme Court judgement affirming the financial independence of the third tier, describing the verdict as apt, capable of

ensuring growth and the infrastructure development needed at this material time.

He however served a caveat that the autonomy would be beneficial if only LG bosses are held accountable for their action if they fail to deliver.

Having a mechanism holding elected officials accountable will put them on their toes to deliver on the goals of the autonomy granted.

He listed; fast and timely implementation of budgets, cash backing of proposed projects, transparency and accountability, ensuring growth and enhancing social infrastructures at the grassroots as some basic objectives of the financial independence of the LGs which he said must not be defeated such that it would prompt calls for reverting to the hitherto

tatus quo.

"Prudent management of scarce resources in the form of monthly allocations should be the watchword for these LG bosses if they could make meaningful impacts on lives of citizens. "Agriculture, which is the mainstay of rural dwellers must be developed beyond subsistence level so farmers will earn value for their efforts by producing in mass for commerce locally and

"Whatever the outcome arising from granting direct allocation to the local governments after the October 19 election in the state will be a yardstick measuring for the success or otherwise of the Supreme Court judgement on this important issue of governance as it affects our nascent democracy," he echoed.

We are constructing a 6km asphaltic road to Tudun Biri Village. This road, when completed, will open up Tudun Biri Village, link it to other communities, boost agriculture in the area, and ease the movement of persons and goods. Similarly, a Skill Acquisition Centre is under construction and we are building a Clinic to cater for the medical needs of the people. We thank individuals and corporate organizations that have commenced various projects in Tudun Biri. May the Almighty God reward them abundantly.

You may recall that shortly after the unfortunate incident, public and private institutions, as well as public-spirited individuals donated funds to alleviate the suffering of victims and families of those affected. We are grateful to the institutions and individuals for their show of compassion and empathy. I thank the Committee led by the Deputy Governor, H.E. Dr. Hadiza Sabuwa Balarabe for their commitment and thoroughness. We have disbursed over Two Hundred and Seventy-Five

Million Naira (N275,000,000) from money donated by individuals, and public and private institutions. I want to use this opportunity to appeal to all those who made pledges to please redeem them, as Mr. President and the Vice President have done.

Our profound appreciation to our dear President, Bola Ahmed Tinubu, GFCR for picking Tudun Biri for the groundbreaking ceremony of the Resettlement Scheme for Persons Impacted by Conflicts. She assured of the Federal Government's continued support for the state's healthcare initiatives, emphasizing the importance of collaboration in achieving the nation's healthcare goals.



### KASUPDA removes temporary structures in Kaduna

aduna State Urban Planning and Development Authority (KASUPDA) has commenced the removal of temporary and informal activities in Kaduna Metropolis.

The Head of Public Affairs Unit of the Authority, Nuhu Garba Dan'ayamaka said areas effected by the action were NDA Bustop, U/Dosa area, Kawo area, Mando rounda about, Rabah road, NAF Club Gate, Katuru Road, and Isa Kaita Road, Alkali Road, Babban Saura area(Millennium City), T/Wada area, Barnawa, High Cost Junction axis among others.

The action he said followed public announcement in the media,

sensitization visits and stakeholder's engagement meetings in order to give the affected people ample time to remove their properties as well as to vacate those places.

The Authority maintained that, in view of the success recorded so far in the urban planning and city beautification, erection of shops, containers, kiosks and signage without approvals as well as the display of wares or goods on side roads were source of concern in view of the environmental harzard, traffic congestion and security threat in the state.

During the enforcement exercise, some of those affected confirmed that, the Authority had informed them, but cited poverty, socio-economic hardship in the country, non-completion of the modern markets exobital price of shops in the markets and neighbourhood centres, high rate of unemployment and insecurity challenges as factors attributed to the informal activities along the roads in the state.

Others confirmed that such places were not meant for business operation but maintained that, they had no other option.

Many effected by the enforcement action appealed to the government for alternative places to enable them carry out their legal business activities.

In the meantime, KASUPDA has reiterated the need for co-operation in the bid to ensure urban sanity and secure environment in the state.

# Former Kaduna Dep Gov hails Uba Sani's peace initiative


ormer Deputy Governor of kaduna State Mr James Bawa Magaji has commended Governor Uba Sani for his humancentered development efforts.
